- WORLD ECONOMY The professional activity of an economist in this field is carried out: in the external economic, monetary and financial sectors at the national and international levels. The training program for economists of this profile includes the study of the legal and economic foundations of concluding international transactions, tariff and customs regulation, diplomacy and negotiation, the practice of foreign exchange, trade and financial transactions.
- STATISTICS According to international experts, a systems analyst is one of the four most sought-after specialists in the world. Without statistics it is impossible to make a reliable forecast, build a business plan. Graduates are in demand in the economic, marketing, financial services of enterprises of various industries, as well as in the departments of social development and labor, migration management in government.
- TAXES AND TAXATION The uniqueness of the "Taxes and Taxation" profile is that it is possible to always be employed. A graduate of the "Taxes and Taxation" profile can work in the civil service (in the State Tax Service of the Kyrgyz Republic, the financial intelligence service of the Kyrgyz Republic, the State Security Service of the Kyrgyz Republic, the Ministries of the Kyrgyz Republic, local authorities); tax auditor, tax consultant; tax manager in Kyrgyz and foreign companies.
- **INSURANCE** Professional activities in this field are carried out in consulting companies, insurance organizations at the national and international levels, and tax authorities. The training program includes the study of

international, state and private insurance.

- FINANCE AND LOAN The professional activity of an economist in this field provides comprehensive knowledge in the field of state and municipal finance, financial management, the securities market, the treasury system, and investment management.
- ECONOMY AND MANAGEMENT AT THE ENTERPRISE The profile "Economics and management at the enterprise" is focused on training qualified specialists in the field of economics of enterprises and organizations. The graduate will be able to work in the economic, financial, production and analytical services of enterprises of various industries, fields and forms of ownership, institutions and organizations, in financial, credit and insurance institutions, municipal and state authorities, scientific and research and professional education organizations
