VI. Successful candidates presentation

- A. Announcement of successful applicants for freshman will be notified individually, and the applicant or his/her representative must confirm it
- B. Announcement of successful applicants for transfer will be notified individually, and the applicant or his/her representative must confirm it
- C. Successful applicants must bring the certificate of examination in person or their representative, and receive a certificate of acceptance and a notice of tuition fees from the Admissions Office of the University.
- D. Successful applicants must complete registration within the specified period, and if they do not register within the specified period, they will be disqualified

VII. Tuition refund

A. Refund criteria

In case of giving up enrollment due to passing other universities or etc after passing or registration at the Joongbu University, if you wish to refund, the full tuition will be refunded.

But if the tuition refund period has elapsed, it will be refunded in accordance with the Ministry of Education Ordinance No. 1 [¬]Rules on University Tuition_→

VIII. Note for students

A. Applicant caution

- 1) Multiple nationalities with Korean nationality and stateless persons are not recognized as foreigners
- 2) Only regular school education courses are recognized that are recognized as having a certain

academic background in accordance with the education-related laws and regulations of the relevant country

B. Documents submitted caution

1) Original documents must be submitted. In case of unavoidable submission of a copy, it is possible to submit it if issuing institution confirms that it is equivalent to original, but the original documents must be submitted after passing and registration. Submitted documents will not be returned.

2) If the submitted documents are written in a language other than Korean or English, a notarized Korean (or English) translation must be attached

3) The period of studying high school course in Korea is submitted a high school record life instead of a certificate of enrollment or transcript

4) If the names on the submitted documents are different, attach a certificate of the same person issued by the court or the head of a diplomatic mission in the relevant country to prove that they are the same person

5) In principle, the financial guarantor is the applicant or the applicant's parents. If the applicant's relative or a third party (relevant country or Korean only) becomes the financial guarantor, submit documents proving the relationship with the applicant (not for illegal residents of Korea)

6) The contact information you providing when filling out the application form must be a place where you can be reached during the application period.

If there is a change, you must immediately notify the Admissions Office of the Joongbu University.

Disadvantages due to loss of contact are on the person

7) Those who have submitted a certificate of expected graduation(completion) when submitting documents among those who have passed Joongbu University submit,(Choose 1 of the below)

- 'Certificate of Apostille Confirmation'

- 'Certificate of Confirmation of Educational Institutions' of the consulate or the embassy at relevant country

- 'Consular confirmation (recognition of academic background)' of the consulate or the embassy at relevant country

C. Other Notice
